then at 2.00 pm visitation, visiting church members  
upto 5.00 pm back home, animals are taken to  
their sleeping places. 1.00 P.m supper then bible  
study upto 9.30 sleep. I call it a day.

Christine Nasimiye wakes up at 6:30 house work which take three hours, at 10:00 AM in the farm which take three hours back home preparing lunch at 12:00 AM then at 2:00 PM visitation upto 5:00 PM back preparing supper then Bible study at 7:30 upto 9:30. Sleep.
