## **TESTIMONY OF IRINE NJOKI MURIUKI** **(ZEPHANIAH'S WIFE)**

I was born in the year 1981 in a village called Tumu Tumu in Nyeri County. I am the fifth born daughter of Christopher Miano and Cecilia Nyarui Miano. We are seven in our family, four sisters and three brothers. In the year 1992 my family migrated from Tumu Tumu, Nyeri County and settled at Mia-Moja, Laikipia County where my dad acquired a piece of land.

I Thank Almighty God for Blessing me with God fearing parents who raised me to be a person whom I am today. I was raised Roman Catholic, we went to church as a family faithfully every Sunday. One day at high school I heard a young girl like me give her personal Testimony about her personal relationship to Jesus Christ. I knew there was a vast difference between her relationship to Jesus and my relationship to Jesus. She and Jesus were friends but Jesus was more like the school principal to me. The only time I went to Him is when I was in trouble.

One glorious day in the year 1998 I Met with pastor Stephen Ngunjiri together with a Baptist deacon who were doing door to door evangelism they preached the word of God to me and my sister. I had many unanswered questions in my life like: Who is God, What is my relationship with Him? Pastor Stephen shared with us Bible, scriptures which shed light to us that we were sinners and deserve eternal judgment. I Realized that it is only Jesus Christ who can save me not my deeds. *Ephesians 2:8-9* Not my parents nor my friends. He read *John 3:16* God is love *Romans 3:23,6:23,5:12,19* I am sinner and *John 1:12*. He said "If you want to be saved you can get saved right here and right now. He asked us if we were you ready to receive Jesus to be you Lord and savior? I felt inside myself today is my salvation day *1 Cor 6:2* I and my sister we prayed a confessing prayer to welcome Jesus to be our personal Savior from that time on I joined Baptist church where I was baptized and I became a devoted church member. It was in this condition that I met my lovely husband Zephaniah Muriuki and in the year 2002. God blessed us with four children Three girls and one boy namely, Vivian Kathambi, Twins daughters HopeJoy Wambui, Glory Wanjiku and Emmanuel Koome. It is my prayer that God will help us to raise our children in the fear of the Lord *Proverbs 1:7*

I thank God for such an opportunity that He has placed upon us to serve in His Kingdom. Currently I am serving in the children department as a teacher. I have led many children to Christ and my passion is to see little children giving their lives to Jesus Christ every day. It seems like yesterday that I trusted the Lord Jesus Christ as my Savior. As they say "time flies " and truthfully with abundant life of Christ, time dissolves into eternity. It just gets better everyday.

Christian foundation. He usually enjoyed the verses from the books of Psalms, Proverbs and New Testament.

However, His Christian life contradicted with the tactics he had acquired from the freedom fighters which resulted to quarreling and chaos among the family members. At the age of three years I started attending the New Apostolic Church where I learnt *Kiroho* (spiritual) songs and songs which are intact in me up to date. This is emphasized by *Prov 22.6* “*train up a child in the way he should go and when he is old, he will not turn from it.*” After sometime I decided to seek a new way of Christian life due to the poor leadership style practiced at the New Apostolic church and joined the Africa Independent Pentecostal Church of Africa (AIPCA) where I was baptized without a clear knowledge of baptism due to lack of a clear/sound doctrine.

## **CHRISTIAN LIFE**

At the age of twelve our late brother Amos Kathawe directed me to a new church; Baptist Church at Timau. *Psalms 118:24* “*This is the day which the Lord has made we will rejoice and be glad in it*” After attending the new church for some time, I felt more touched by the preaching and the church activities unlike the former church where people could smoke even in the church. We became faithful at the Bible Baptist Church together with my sister Mary Kaniiru.

I became an active member of the Sunday School under teacher Kim Madaus and Christine Chebet. I enjoyed the Bible readings more than before. As a small boy the question of life after death disturbed me very much. After that I started enquiring from my Christian fellows including my Sunday School teacher Chebet. One day she concluded that I am a sinner and I cannot save myself according to the Word of God.

I gave my life to Jesus Christ to be my Savior on 10<sup>th</sup> Dec 1995 after hearing the word of God from my Sunday school teacher when I realized I was a sinner and could not save myself neither my parents nor my family members but God alone.

My devotion to Christ was boosted by the verse from *Luke 18:10-14*, where the Publican and the Pharisee were praying. After a moment of meditation I found myself to

be like the Publican and I started crying in front of the others. I decided to humble myself before God so that I could be exalted. Our Sunday School teacher shared the following bible readings; *John 3:16, Romans 3:23, 6:23* which proved to me that I was a sinner specifically due to the poor Christian family background. So she told us that if one accepts Jesus Christ as his/her personal Savior he/she becomes a child of God (*John 1:12*) and one enjoys eternal life. Christine Chebet led me to recite a confession prayer. I was happy as a king after knowing that my name was written in the eternal book and my sins were forgiven. She challenged me to share the good news with my parents and friends. After hearing the news, my parents were very happy and I became a follower of Christ and was baptized on 26/03/1996

In 2002 I got married to Njoki Miano under customary law and we are blessed with four children. Three daughters and one son namely Vivian Kathambi born 29<sup>th</sup> September 2002, Hope Joy Wambui born 21<sup>st</sup> June 2008, Glory Wanjiku born 21<sup>st</sup> June 2008, Emmanuel Koome born 22<sup>nd</sup> August 2010. We acknowledge that children are a heritage of the Lord and the fruit of the womb is his reward *Psalms 127:4*. We thank Almighty Father because he helped Vivian to confess her sins and she has accepted Jesus Christ as her Lord and Savior and baptized in 2012.

## **CHURCH MINISTRY /PASTORAL MISSION**

While assisting in Sunday school activities I started growing spiritually with the help of my mentor pastor Ngunjiri at Timau Bible Study class. Later on I started serving in children ministry after completing a Bible course and attained two certificates. At children ministry I served as a junior teacher. While serving in the ministry I enrolled for a supplementary course at Mount Kenya Bible College at Nanyuki while my mentor was

nurturing me with the word of God. As iron sharpens iron so a person sharpens a friend  
*Proverb 27:17* After the departure of Pastor Chuck we continued serving alongside Chebet, Rose, Mercy Jethro at Sunday school while Ngunjiri became a senior pastor and David Kimathi was in charge of the youth,
